Sub: Participation in CPHI 2006, Paris, France.

At the outset, we thank the members who have taken part in CPHI 2005 through council. After successfully organizing Pharmexcil Pavilion in CPHI 2005, we are planning to organize 'India Pavilion' in CPHI 2006 to be held at Paris, France during 3-5th October 2006, by taking a space of 477 sq.mtrs in **Hall No.5A**.

Highlights of the Indian-Pharmexcil Pavilion are as follows:

- The organizers have agreed to officially declare the area as India Pavilion.
- The minimum space to be booked by the exhibitors outside our Pavilion is 20 sq.meters (shell scheme) and 30 sq.meters (bare space). **However, in our Pavilion minimum stall size is 12 sq.meters**
- Approximate cost would be Rs.27,000-29,000 per sq.meter depending on exchange rate and other variable costs.
- The stall cost includes minimum furniture like carpet, three chairs, one table, one information counter, one stool, three/four spot lights, dust bin, one power socket, overall India branding etc.
- The space is ideally located at the entrance between hall No. 5A and 6
- Floor plan of the Pavilion is placed in our website.
